If – I Repeat IF – EoP Axis Civilian Political leadership (I) vote ‘No EoP TRC’ on 16 Sep 2019 [01 Aug: [Pta Central Sheriff: Chris Jakobus: Re: H 111/19: LJ v Lindiwe Sisulu & 8 Others](#)¹]; in H 111/19: LJ v LS [16 May: [LJ v LS Court Filing](#)²] (II) without having provided their nation’s military leadership with an opportunity to hold an ‘EoP TRC: Responsible Freedom’ or ‘No EoP TRC: Death Spiral Slaughterhouse Genocide’ military leadership vote [30 Aug: [Hillary Soros: Draft: DNC Consent to EoP RH FR Ethics Control of National Security Definition](#)³; 22 Jun: [LJ v LS Notice to Pres Trump and 2020 US Presidential Candidates](#)⁴]; (III) herewith EoP MILED Clerk Draft Plan for EoP Axis Military Democracy Martial Law implementation of EoP UN Resolution.

[A] Military Elite EoP TRC or No EoP TRC Vote:

Depending on EoP Axis MilOrg (A) Majority Vote Wins or (B) Believability Vote Wins [06 Aug: [LJ v LS CEO Req for Invest Info: Peter Blanken & Michael Burry](#)⁵], voting process:

[A1] All Generals – currently serving or retired – vote: EoP TRC voters sign their EoP Axis NatSec Oath [[eop-axis-oath](#)⁶]; No EoP TRC voters decline to sign any EoP Axis Oath.

[A1a] If EoP TRC: No EoP TRC Generals resign, EoP TRC Generals can allow Colonels to Captains to vote; or proceed to [B] Military Judges Vote or [C] EoP TRC: EoP UN Resolution Martial Law.

[A1b] If No EoP TRC: All Generals consent/authorize H 111/19: LJ v LS ‘No EoP TRC: Lara & Tim Siberia Assisted Suicide’ provisions.

[B] Military Judges EoP TRC or No EoP Vote:

Depending on EoP Axis Military Judges (A) Majority Vote Wins or (B) Believability Vote Wins [06 Aug: [LJ v LS CEO Req for Invest Info: Peter Blanken & Michael Burry](#)^{bid}], voting process:

[B1] All Military Judges – currently serving or retired – vote: EoP TRC voters sign their EoP Axis NatSec Oath [[eop-axis-oath](#)^{bid}]; No EoP TRC voters decline to sign any EoP Axis Oath.

[B1a] If EoP TRC: No EoP TRC Mil Judges resign, EoP TRC Mil Judges allow lower court military judges/lawyers to vote; or proceed to [C] EoP TRC: EoP UN Resolution Martial Law.

[A2] If No EoP TRC: All Military Judges consent/authorize H 111/19: LJ v LS ‘No EoP TRC: Lara & Tim Siberia Assisted Suicide’ provisions.

[C] EoP TRC: Martial Law to Implement EoP UN Resolution:

[C1] Joint Chiefs/Mil Judges request Presidential Executive Order to establish EoP Axis NatSec Oath legal office requiring:

[C2a] All Judges – including lower court military judges depending on Military Judges decision in [B1a] – ordered to Sign EoP Axis NatSec Def Oath; or are allowed to resign or are fired.

[C2b] All Lawyers – including military lawyers depending on Military Judges decision in [B1a] – ordered to Sign EoP Axis NatSec Def Oath; to keep their license to continue to practice law.

[C2c] All Mainstream Media publishers, editors & journalists ordered to Sign EoP Axis NatSec Def Oath; to keep their FCC media broadcasting license, and publish FCC license media stories.

[C2d] All National legislators ordered to Sign EoP Axis NatSec Def Oath; or (a) lose parliamentary legislation license voting privilege; (b) resign / be fired.

[C2e] EoP Axis NatSec Oath legislators authorize UN Amb to Vote Aye: EoP UN Resolution.
